HEI INTERPRETING THE HEI-SOURCED MEASURE SET

- Member race and ethnicity is sourced from the California Healthcare Eligibility, Enrollment, and Retention System (CalHEERS).
- Health Evidence Initiative (HEI) data excludes Covered California for Small Business (CCSB), includes only Qualified Health Plan (QHP) submitted claims, and includes allowable adjustments resulting in small changes to measure specifications.
- Total rates are not displayed for measures stratified by race and ethnicity due to small discrepancies compared to publicly reported HEDIS and QRS measure rates, resulting from HEI data characteristics outlined above.
- All HEI-sourced rates are subject to a quality assurance process including assessing year-over-year results, comparison to QRS publicly reported results where applicable and other industry norms.
- Rates with fewer than 11 cases in the numerator have been suppressed to comply with the Health Insurance Portability and Accountability Act of 1996 (HIPAA) Privacy Rule's de-identification standard.
- Rates with fewer than 30 cases in the denominator have been suppressed because such small rates can be unreliable.

- Medication is a critical part of treatment for individuals with OUD; this measure includes the following four types of Food and Drug Administration-approved drug products:
 - Buprenorphine
 - Oral naltrexone
 - Long-acting, injectable naltrexone
 - Methadone
- Individuals who engage in treatment with medication are less likely to exhibit withdrawal or craving symptoms, and more likely to engage in mental health therapy
- Indicator: Higher is better
