Policy Considerations

- Advanceable premium assistance and/or refundable credit
- Reconciliation requirements
- State entity(ies) responsible for program administration, payments to carriers/consumers and program oversight
- Development of California-specific required contribution parameters
- Funding source and duration

Operational Considerations

- System changes to calculate, display, transmit, report and reconcile state premium assistance amount
- Consumer noticing, outreach and education
- Potential changes to tax form process



POTENTIAL POLICY AND OPERATIONAL CONSIDERATIONS: ENHANCE AND/OR EXTEND PREMIUM ASSISTANCE

- Carrier Considerations
 - System changes to capture and apply state premium assistance amount
 - Establishment of processes for receiving and reconciling state premium assistance
- Agency Coordination and Required Approvals
 - State authorizing legislation and budget appropriation
 - Federal approvals: TBD
 - Establishment of payment process with carriers if premium assistance is advanceable
 - Coordination with any impacted state and county agencies



POTENTIAL POLICY AND OPERATIONAL CONSIDERATIONS: EXTEND AND/OR ENHANCE COST SHARING SUPPORT

Policy Considerations

- Development of California eligibility and/or cost sharing variants
- Funding source and duration
- Implications for current "silver loading" approach
- State entity(ies) responsible for program administration, payments to carriers, and oversight

Operational Considerations

- System changes to determine eligibility, display appropriate plans, transmit and report cost sharing assistance amount as needed
- Cost sharing payment approach



POTENTIAL POLICY AND OPERATIONAL CONSIDERATIONS: EXTEND AND/OR ENHANCE COST SHARING SUPPORT

- Carrier Considerations
 - Plan design and approval process
 - Rate development and "silver loading" impacts
 - Establishment of processes for receiving and reconciling state assistance
- Agency Coordination and Approvals
 - State authorizing legislation and budget appropriation
 - Federal approvals: TBD
 - Establishment of carrier payment process if cost sharing is directly funded
 - Coordination with any impacted state and county agencies



POTENTIAL POLICY AND OPERATIONAL CONSIDERATIONS: CALIFORNIA INDIVIDUAL MANDATE AND PENALTY

- Policy and Operational Considerations
 - The coverage that qualifies (minimum essential coverage)
 - Penalty amount for not maintaining coverage
 - Exemptions available
 - Use of penalty revenue
 - Administrative processes (penalty collection, granting of exemptions, reporting, tax code changes)



POTENTIAL POLICY AND OPERATIONAL CONSIDERATIONS: REINSURANCE PROGRAM

- Policy and Operational Considerations
 - Reinsurance model (attachment point or condition-based)
 - 1332 waiver
 - Funding source and duration
 - State entity(ies) responsible for program development and administration, payments to carriers and program oversight
